# Workshops

## Workshop 1: How to address Criterion 2 in the Referencing Report?

Criterion 2 for referencing national qualifications levels to the EQF states that there must be a clear and demonstrable link between the qualifications levels in the NQF and the level descriptors of the EQF.

This workshop will explore and discuss transparent ways of responding to this criterion and will address the following questions:

How to best indicate this "clear and demonstrable link" to the international audience?

How to address the concept of "best fit"?

How to present the relationship between the NQF and the qualifications framework for Higher Education?

How to deal with the fact that qualifications that have been considered as "equal" so far (for example, the upper secondary school leaving certificate) will be related to different EQF levels in different countries?

## Workshop 2: How to address Criterion 4 in the Referencing Report?

Criterion 4 is related to transparent procedures for inclusion of qualifications in the national qualifications framework or for describing the place of qualifications in the national qualification system. A crucial question in this context is related to providing arguments and evidence when allocating qualifications to the NQF. This workshop will address the following questions:

How and in how much detail should evidence be provided in the EQF referencing report?

How to apply the concept of "best fit" when classifying qualifications in an NQF?

How to balance technical analysis (comparing descriptors) and social approach (e.g. consulting stakeholders)?

How to balance learning outcomes and input?

How to ensure quality in this process?
